



## Effective risk-based planning

Compliance with International Professional Practices Framework and in particular standards that expect use of risk-based methodologies relating to planning, methods and reporting necessitates a transparent understanding of both the risk appetite of your organisation and the risks that it faces in delivering its strategic and operational objectives.

An essential feature of delivering a risk-based service is the establishment of definitions of risk that are supported by management, understood by internal auditors and used as a common and consistent basis for deciding what matters most in terms of the need for assurance from internal audit and that opinions are consistent, both in terms of how they are expressed as well as how they are seen as positively helping to improve processes relating to risk management, governance and control..

Our RiskMate software is focused on:

- Defining risk materiality across a range of activity categories so that a common understanding of what matters most is achieved,
- Recognition of risk at both inherent and residual levels so that the materiality of the control risk can be used as a basis for the direction of the internal audit plan, and
- Providing a means by which recommendations made to improve processes can be tracked as tasks assigned to relevant managers.

RiskMate therefore provides a logical approach to using risk as a basis for internal audit through defining risks in a common framework that can be used to establish the auditable areas, facilitate meetings with auditees, assess materiality of risks as a basis for providing opinions and reflect a real time source of providing assurance to the Audit Committee.

# Informed reporting

The system is designed to provide a range of management information that identifies risk profile at inherent and residual levels, provides a basis for assessing where are the key areas of concern and where these have been mitigated to an acceptable degree, tracks outstanding actions and sends email reminders to managers regarding agreed actions and timelines.

Trend analysis is also available to provide statistics regarding key on-going concerns and movements.

Further portals allow third party reporting of concerns in the form of both Serious Incidents and Whistleblowing, which are managed through a dedicated and confidential registration process linked to named managers within your organisation.
